REACH regulation for chemicals according to directive (EG) No. 1907/2006 ECHA list of registered substances of 14th June 2023

Dear Sir or Madam,

SVHCs (substances of very high concern) are chemical compounds which were identified under the REACH regulation with specific hazardous properties and are regularly listed and published by the ECHA.

Concerning the European REACH regulation we are acting accordingly and with the necessary care. However, we do not supply chemicals, substances or synthesises. We do supply products, to which during the production process a specific form is given, that affects the function in a stronger measure than the chemical composition.

Within the intended way of using these products, they do not emit any substances and do not contain any dangerous substances beyond the limit of 0,1%.

According to Article 33 of the REACH regulation and the registered substances of very high concern with all enhancements of ECHA of 14th June 2023 following from Article 59 of the REACH regulation, we shall inform our customers before every shipment about any article that contains a SVHC above 0.1% w/w.

Furthermore we can assure that we are in a constant dialogue with our suppliers in the supply chain. In addition to that our suppliers are committed to inform us immediately, if the REACH Conformity cannot be guaranteed anymore.
